Directions, Parking and Hotel Reservation Information

Location

The Symposium will be held in the Frick Chemistry Building, Princeton University, Princeton NJ 08540.

Parking

Visitor parking is available in Lot 21. Frick Chemistry Building is a short walk from Lot 21. A map showing the walking route is attached. You can also take a shuttle. The East Commuter shuttle picks up at lot 21 and drops off by Jadwin Hall, which is adjacent to Frick Chemistry.

Here is an interactive map of campus and a pdf version of it.

Street parking is an option if you arrive early on campus, but make sure you bring plenty of quarters.

Driving Directions to Visitor Lot 21 (47 Faculty Rd, Princeton, NJ 08540)

From the NORTH/ NEW YORK CITY

Take the New Jersey Turnpike south to Exit 9 (New Brunswick). After the toll booths, take the first right turn onto the ramp for Route 18 north. Soon after you enter Route 18, take the left side of a fork in the road, staying in the right lane. Immediately bear right for an exit to U.S. Route 1 south/Trenton. Drive south on Route 1 for about 18 miles, turn right onto Washington Road.

From the WEST

Drive east on Interstate 78 into New Jersey. Exit onto southbound Interstate 287 (toward Somerville). Follow signs for Routes 202/206 south. Go south on 202 for a short distance and then follow signs to 206 south, which will take you around a traffic circle. Go south on 206 for about 18 miles to Nassau Street (Route 27) in the center of Princeton. Turn left onto Nassau Street, and follow it to the third traffic light, which is Washington Road, turn right onto Washington. Travel on Washington to the first light and turn left onto Prospect Avenue. Alternative from the WEST: Take the Pennsylvania Turnpike east to the exit for Route 1 north. Travel on Route 1 north for approximately 23 miles. Turn left onto Washington Road.

From the SOUTH

If you are coming from southern New Jersey, we recommend that you take Interstate 295 north (instead of the New Jersey Turnpike), exiting at Route 1 north (exit 67). Travel about three miles north on Route 1, turn left onto Washington Road.

From the PHILADELPHIA AREA

Take Interstate 95 north into New Jersey and exit at Route 1 north (exit 67). Travel about three miles north on Route 1 to the Washington Road exit, which is a traffic circle. Go three quarters of the way around the circle and turn right (between the gas stations) toward Princeton. Proceed on the Washington Road and follow "Directions to Lot 21".

From the **EAST**

Take Interstate 195 west (toward Trenton) to the exit for Interstate 295 north. Drive seven miles to the exit for Route 1 north (exit 67). Travel about three miles north on Route 1, turn left onto Washington Road. See direction to Lot 21

Directions to Lot 21

Heading north on Washington Road (away from Route 1), turn right onto Faculty Road.

(If you are heading south on Washington Road from Nassau Street/Route 27, turn left onto Faculty Road.)

After passing Jadwin Gymnasium, turn left on Fitzrandolph Road and then take the first left turn into Lot 21.

Taking the Train

Getting to Princeton University by train **from New York City**

Take the New Jersey Transit northeast corridor line from New York Penn Station to Princeton. You will have to change trains at Princeton Junction and take a smaller train, called the "dinky" to Princeton.

Getting to Princeton University by train **from Philadelphia**

Take the SEPTA train from Philadelphia to Trenton. Then take New Jersey Transit northeast corridor line from Trenton Station to Princeton Junction. You will have to change trains at Princeton Junction and take a smaller train, called the "dinky" to Princeton.

Train Station to Frick Chemistry

Take the Forrester-PPPL shuttle from the Princeton "dinky" station to the Lewis Library, which is located a block north of Frick Chemistry, on Washington Road.
